CHED Memorandum Order(CMO) No. <u>05</u>, s. 2005

Subject: Addendum to CMO 35, S. 2004, Implementing Guidelines of the

Higher Education Development Project- Faculty Development

Program (HEDP-FDP)

In fulfillment of the its commitment to support the upgrading of higher education faculty qualifications, the CHED, through Commission en banc (CEB) Resolution no. 044 s. 2005 dated February 14, 2005, approved the provision for substitutes for full-time scholars under the HEDP-FDP in accordance with the following guidelines:

I. Eligibility for substitute assistance

Qualified as full-time scholars are:

 Faculty scholars who are completely released by the Sending Higher Education Institutions (SHEIs) from full-time teaching load.

b. Scholars who are taking a full-time study load with a minimum of twelve (12) units as certified by their Delivering Higher Education Institution (DHEI), except during the last term when a minimum of 9 units maybe considered as full-time load.

II. Conditions

The grant of subsidy to the SHEIs for their substitute teachers shall be governed by the following:

- a. Only SHEIs with faculty scholars enrolled during regular semesters or trimesters shall be given the subsidy;
- A maximum of twelve (12)-unit load per substitute per term (semester or trimester) shall be given subsidy. Units in excess of the twelve (12) units shall be shouldered by the SHEI;
- c. The rate of the three (3) unit load per month per substitute shall be based on the hiring rate of the SHEI but not to exceed P1,120 per unit per month or P280 per hour. The expense for the substitute teachers of the Sending HEI specified in item 1 shall be reimbursed directly to the SHEI after the submission of the accomplished form (Attachment 1); and

d. Source of funding shall be the HEDP-FDP scholarship allocation from the HEDF.

III. Coverage

The Guidelines shall apply to all incoming scholars starting Phase II (AY 2005-2006) of the HEDP-Faculty Development Program.

This CMO shall take effect immediately and shall be in force until otherwise revoked.
