CHED MEMORANDUM ORDER No. 09 Series of 2015

SUBJECT: AMENDMENT TO CMO NO. 25, SERIES OF 2012, ENTITLED **IMPLEMENTING** "CRITERIA AND **GUIDELINES FOR** THE IDENTIFICATION, SUPPORT AND DEVELOPMENT OF CENTERS OF EXCELLENCE (COEs) AND CENTERS OF DEVELOPMENT (CODs) FOR THE LITERATURE PROGRAM"

In accordance with the pertinent provisions of Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994," and for the purpose of establishing Centers of Excellence (COEs) and Centers of Development (CODs) that serve as potent catalysts in Literature education needed for the development of world-class scholarships, nation building and national development, the criteria and implementing guidelines for the identification, support and development of COEs and CODs for the Literature program as embodied in CHED Memorandum (CMO) No. 55, series of 2006 and CHED Memorandum Order No. 25, series of 2012 shall be adopted. Per Commission en Banc Resolution No. 139-2015, dated March 30, 2015, the Annex of CMO No. 25, series of 2012 is hereby amended as follows:
